5. To review, discuss and act on issues related to the remodel and construction of the District facilities, including, but not limited to, planning, design and budgeting, financing, and to engage an engineer and architect.
6. To receive a report regarding applications for FEMA grants arising from emergency services rendered.
7. To receive and approve the District's financial report, including the financial condition of the District and the District's investments, to pay the District's bills, and act on resolutions required related to bank accounts.
8. To review and revise the District's 2023 budget.
9. To receive a report from the Huffman Fire and EMS Department.
10. To review, discuss and act on the acquisition and financing of new vehicles, equipment, and apparatus.
11. To review and approve expenditures required for the construction, repair, maintenance and replacement of the District's real property, facilities, signage, vehicles, apparatus and equipment.
12. To approve the sale or disposal of surplus and/or salvage property pursuant to Texas Health and Safety Code §775.251.
13. To review and act on the purchase, sale or lease of real property, including financing.
14. To create, modify or adopt ESD policies and procedures.
15. To meet in Closed Session pursuant to Government Code §551.071 to consult with legal counsel regarding pending or contemplated litigation, settlement offers or on matters which require confidentiality under the Texas Disciplinary Rules of Professional Conduct of the State Bar of Texas and Tax Code §323.3022 to discuss sales tax matters.
16. To meet in Closed Session pursuant to Government Code §551.072 to deliberate regarding real estate matters.

17. To meet in Closed Session pursuant to Government Code §551.074 to discuss personnel matters.
18. To review and act on matters discussed in closed session.
19. To review, discuss and act on District personnel matters including compensation, benefits, scheduling, retention, hiring and/or termination of District employees.
